**SPECIAL BUSINESS:**

**1. Increase in borrowing limits of the Company**

To consider and if thought fit, to pass with or without modification(s), the following resolution as a **Special Resolution:**

“Resolved that in pursuant to the provisions of Section 179, 180(1)(c) and other applicable provisions, if any, of the Companies Act, 2013 read with the relevant rules made thereunder, consent of the members be and is hereby accorded for accepting and obtaining fund and non-fund based credit facilities including Bank Guarantee, letter of credit, overdraft facilities, cash credit, working capital demand loan, short term borrowings, term borrowings, from any one or more banks, companies, bodies corporate or financial institutions or any other lending institutions from time to time, in one or more tranches, in such a manner that the outstanding borrowings by the Company pursuant to any resolution, shall not exceed INR 45,000 Mn (Rupees Forty Five Thousand Million only) at any point in time.

Resolved further that the Board of Directors of the Company be and are hereby authorized to do all such acts, deeds and things that may be deemed necessary, proper, expedient or incidental for the purpose of giving effect to the aforesaid resolution.”

**NOTES:**

1. A member entitled to attend and vote at the meeting is entitled to appoint a proxy to attend and vote on a poll instead of himself / herself and such proxy need not be a member of the company. Proxies, in order to be effective, must be received at the registered office of the company, duly completed and signed, not less than forty-eight hours before the commencement of the meeting. A proxy form is enclosed with this notice as may be applicable, if any.

Proxies submitted on behalf of the companies, societies etc., must be supported by an appropriate resolution/ authority, as applicable. A person can act as proxy on behalf of members not exceeding fifty (50) and holding in the aggregate not more than ten percent of the total share capital of the company. Provided a member holding more than ten percent of the total share capital of the company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other person or shareholder. A proxy holder needs to show his identity at the time of attending the meeting as may be applicable, if any.

2. During the period beginning 24 hours before the time fixed for the commencement of the meeting and ending with the conclusion of the meeting, a member would be entitled to inspect the proxies lodged for this meeting, at any time during the business hours of the company, provided that not less than three days of notice in writing is given to the company for the said purpose as may be applicable, if any.

**ITEM No. 1**

In terms of the provisions of section 180(1)(c) of Companies Act, 2013, the Board of Directors of the Company cannot, except with the consent of the members in a general meeting through special resolution, borrow money, where the money to be borrowed, together with the money already borrowed by the company exceeds aggregate of its paid-up share capital, free reserves and securities premium.

Accordingly, the Board of directors in its meeting held on November 06, 2025, subject to the approval of shareholders have accorded their consent to increase the borrowing limits of the Company from INR 30,000 Mn to INR 45,000 Mn in such a manner that money to be borrowed together with the moneys already borrowed by the Company pursuant to any resolution, shall not exceed INR 45,000 Mn.

Your Directors recommend the above Special Resolution for your approval.

None of the Directors/Key Managerial Personnel and their relatives are in any way, concerned or interested, financially or otherwise, in the resolutions set out at item no. 1 to the extent of their shareholding in the Company, if any.
