Indian Continent Investment Limited is person acting in concert with Bharti Telecom Limited, Promoter of Bharti Airtel Limited.</p> <p>4. Pursuant to the specific provisions of the Companies (Significant Beneficial Owners) Rules, 2018 (SBO Rules), the Company has submitted the details of the Bharti Enterprises (Holding) Private Limited (Holding Company) with the Registrar of Companies. SEBI/HO/CFD/CMD1/CIR/P/2018/0000000149 dated December 7, 2018, the effective holding details filed by the Company pursuant to SBO Rules, have been included in the shareholding pattern in prescribed format.</p> <p>6. 1,011,520 fully paid equity shares held by Mr. Gopal Vittal MD &amp; CEO has been disclosed under Directors &amp; their relatives category and to avoid duplication the same has not been disclosed under Key Managerial Personnel category.</p>

Number of Shares Underlying Outstanding Convertible Securities of the Company disclosed above is computed assuming 100% conversion of US \$64.20 Million, 1.50% Foreign Currency Convertible Bonds due 2025, issued by the Company as per the terms and conditions of the issue. The initial conversion ratio and initial conversion price are subject to certain adjustments and accordingly may affect the total diluted share capital.</p> <p>2. On Saturday, September 28, 2024, 8,490 Equity Shares were debited from the demat account (maintained with NSDL) of Bharti Airtel Employees' Welfare Trust (ESOP Trust) of the Company towards the exercise of ESOPs by eligible employees, however, since the transfer of equity shares is settled on T+1 basis as per the process of depository, such shares were credited into demat accounts of ESOP allottees (maintained with CDSL) post closure of quarter ended on September 30, 2024 (i.e. on October 01, 2024). Accordingly, such shares, being under settlement process of depository, were neither in NSDL account of ESOP Trust nor in the CDSL account of employees as on September 30, 2024.
