The paid-up equity share capital of the Company includes 6,093,282,313 fully paid equity shares of face value of INR 5 each and 1,110,668 partly paid equity shares of face value of INR 5 each (paid-up value INR 1.25 each). The difference in paid-up shares vis-a-vis above shareholding pattern, is on account of 178,493 shares on which call money has already been received from the concerned shareholders, however, their shares could not be converted by Depositories from partly to fully due to technical errors in their demat accounts. These shares will be converted in due course, upon request from such shareholders. 2. Bharti Telecom Limited is promoter of Bharti Airtel Limited. 3. Pastel Limited is a member of Promoter Group of Bharti Airtel Limited in accordance with Regulation 2(1)(t) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 read with Regulation 2(1)(pp) of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 and is neither Promoter nor a person acting in concert with Promoter, Bharti Telecom Limited, under Regulation 2(1)(q) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and Viridian Limited is person acting in concert (PAC) with Pastel Limited. 4. Indian Continent Investment Limited is person acting in concert with Bharti Telecom Limited, Promoter of Bharti Airtel Limited. 5. Pursuant to the specific provisions of the Companies (Significant Beneficial Owners) Rules, 2018 (SBO Rules), the Company has submitted the details of the Bharti Enterprises (Holding) Private Limited (Holding Company) with the Registrar of Companies. In compliance with the requirement of SEBI circular no. SEBI/HO/CFD/CMD1/CIR/P/2018/ 000000149 dated December 7, 2018, the effective holding details filed by the Company pursuant to SBO Rules, have been included in the shareholding pattern in prescribed format. 6. 30051 fully paid equity shares held by Mr. Shashwat MD & CEO and 1184348 shares held by Mr. Gopal Vittal Executive Vice Chairman has been disclosed under Directors & their relatives category and to avoid duplication the same has not been disclosed under Key Managerial Personnel category. 7. BHARTI ENTERPRISES (HOLDING) PRIVATE LIMITED is a holding Company of Bharti Telecom Limited, holding Nil share in Bharti Airtel Limited. 3. During the quarter under review, the Company undertook a Rights Issue, pursuant to which the entire partly paid-up equity shareholding of the Promoter and Promoter Group stood converted into fully paid-up equity shares.
