# स्ट्रीट लाइट बर्बाद कर रही कीट-पतंगों का भोजन

विशेषज्ञों का दावा, पेड़ों के पत्ते कड़े होने से पेट नहीं भर पा रहे



बीजिंग, एजेंसी। रोशनी की ओर खिंचे चले आने वाले कीट पतंगों के लिए रात भर सड़कों पर जलने वाली लाइटें ही उन्हें भूखे रहने को मजबूर कर रही हैं। ऐसे में कई प्रजातियों पर खतरा मंडरा रहा है। हालिया अध्ययन में इस बात का खुलासा हुआ है।  
इससे पहले कई ऐसे शोध हुए जिसमें बढ़ रहे तापमान से कीटों की प्रजातियां खतरों में हैं और कृत्रिम रोशनी यानी स्ट्रीट लाइटों का असर चिड़ियों या कीड़ों की आंखों पर पड़ा रहा है। अब वैज्ञानिकों ने पाया कि पूरी रात स्ट्रीट लाइटों जलने से पेड़ों की पत्तियां सूख हो रही हैं, जिससे कीड़े उन्हें खा नहीं पा रहे हैं। चीन के अकेडमी ऑफ साइंसेज के शोधकर्ताओं ने अध्ययन में दावा किया है।  
गायब हो सकते हैं कीट : शोधकर्ताओं ने बताया कि शहर में मौजूद पेड़ों की पत्तियों की जांच की गई। जांच के दौरान करीब 5500 पत्तियों का परीक्षण किया गया। इसमें



### खाद्य श्रृंखला पर असर

शोध करने वाले वैज्ञानिक ज्ञान ने बताया कि खाने की कमी से कीटों की आबादी कम हो सकती है और प्रजाति लुप्त होने से पारिस्थितिकी तंत्र पर प्रभाव पड़ेगा। शाकाहारी कीटों की संख्या में कमी और शिकारी कीटों की अधिकता होती जाएगी, जिससे इसीनी गतिविधियां पर असर पड़ने की आशंका है। इसके अलावा खाद्य श्रृंखला में भी बदलाव होने के आसार रहेंगे।

### रात की चमक 10% बढ़ी

शोधकर्ताओं ने बताया कि कृत्रिम प्रकाश की चमक के स्तर को लगभग 10 प्रतिशत तक बढ़ा दिया है। उन्होंने चिंता जताई कि रात में कृत्रिम प्रकाश के संपर्क में आनेवाले पेड़-पौधे अपने प्रकाश संश्लेषण की अवधि को बढ़ा सकते हैं। इससे अपार प्रकाश संश्लेषण की प्रक्रिया होगी तो पौधों के जीवन की प्राकृतिक पारिस्थितिकी पर प्रभाव पड़ने की आशंका है।

30 जगहों से नमूने जुटाए गए और हर स्थान से प्रकाश की मात्रा, कठोरता, पानी की मात्रा और रासायनिक गुणों को मापा गया। इस शोध के निष्कर्ष फ्रंटियर्स इन प्लान्ट साइंस में प्रकाशित हुए हैं। शोध के लेखक डॉ. शुआंग ज्ञान ने बताया कि बीजिंग में जापानी पैगोडा और हरे राख के पेड़ के पत्तियों को कीट पसंद करते हैं। उनके मुताबिक, इन पेड़ों में पत्ते मुलायम होते हैं जिन्हें कीड़े पसंद से खाते हैं। लेकिन शोध में पाया गया कि स्ट्रीट लाइटों जलने से ये पत्तियां इतनी सूख हो गई कि कीड़े खा नहीं सकते थे।
